# **OPEN SESSION**

Open Session reconvened at 4:07 p.m.

### **MEMBER CONCERNS WITHIN AFA'S PURVIEW**

- 1. <u>Zoom broadcast of Executive Council open session</u>. A member suggested that the open session of Executive Council meetings be broadcast via Zoom to encourage member participation.
- 2. <u>Anti-union sentiment at SRJC</u>. A member expressed concern that a union-hostile environment is developing at the college. The member requested direction on how to strengthen AFA and repair the negative image.
- 3. Parking fee for faculty. A member requested that AFA work to end parking fees for faculty.
- 4. North Bay Jobs with Justice. A member reported that there are many ways to become involved in supporting social justice causes through AFA's affiliate membership with NBJwJ. Currently, the Kaiser Permanente mental health care workers are on strike. To support them, one can visit the picket line MWF 8a-3p at 401 Bicentennial Way, donate via their GoFundMe site, or sign their petition. The workers at Amy's Kitchen are continuing the effort to unionize. Their workers seek support from other organizations to solidify their cause.
- 5. AB 1856. A member announced that there is a new bill that proposes part-time faculty be permitted to work up to 85% rather than 67%. The bill allows associate faculty the opportunity to make a living wage working at one campus, rather than continuing the practice of "campus hopping" to get enough work. Last year, a similar bill was presented, but was not signed by the governor. The member encourages faculty to reach out to the legislators to encourage them to sign the bill.

# 3. Appointment of AFA Representatives to District-wide Committees for 2022-23: ITG, Fringe Benefits, PDC, SGA

- The following nominations were made:

- A motion was made and seconded to appoint the candidates as a slate.
- A call was made for further comments. There being none, a vote of the Council was conducted.
- The Council voted to appoint the candidates as a slate (15 in favor).
- The representative to the SGA position will remain open until filled.

# 4. Appointment of AFA Representatives to District-wide Committees for 2022-23: DOC

- This item was moved from a Discussion Item.
- A motion was made and seconded to appoint the candidate to the committee.
- A call was made for further comments. There being none, a vote of the Council was conducted.

• The Council voted to appoint Salvador Rico to the DOC (unanimous show of hands).

#### **PRESENTATION**

- 1. Public Service Loan Forgiveness (PSLF). Presented by Casandra Hillman.
  - The overburdensome debt issue has resulted in a reduction in the number of students attending institutions of higher education – students don't want to be in debt upon leaving school.
     President Biden recently approved several loan forgiveness options. <u>Student Loan Relief Fact</u> Sheet.
  - Faculty may be eligible for these programs, including:
    - ° \$10,000 in relief for those with annual income less than \$125,000
    - ° A 20- and 25-year forgiveness program for those making consistent payments
      - 20 year from accrual for undergraduate forgiveness
      - 25 years from accrual for graduate forgiveness.
    - Public Service Loan Forgiveness program
  - The PSLF program will benefit faculty the most
    - ° The process can be arduous, so apply now
    - Applicants previously denied forgiveness are encouraged to reapply
    - Part-time/associate faculty positions now count toward the 10-year employment rule.
    - ° Some requirements include:
      - Make 120 payments (10 years of monthly payments)
      - Work for a non-profit for 10 years.
    - ° The deadline to apply for PSLF is October 31
    - Fill out the form online, send it to all the colleges/non-profits of previous employment
    - ° Send your completed form to Bridget Hodenfield in HR
    - NOTE: Only direct loans are forgiven. Loans must be consolidated to government subsidized loans to be considered for forgiveness.
  - Faculty are welcome to contact Casandra Hillman with any questions regarding the process.
  - Questions & Comments
    - O: What counts as "non-profit" employment? Is teaching considered a non-profit field?
      - ⇒A. All non-profits are eligible. Most schools and colleges are classified as not-for-profit businesses.

Comment: Please reapply if you applied and were denied previously. The application process is less rigid now.

Q. Part-time faculty work more than the number of hours they receive monetary payment. Associate faculty would receive a better percentage if other service to the college was included in the calculation that HR makes when figuring total hours worked. Can AFA negotiate an MOU (e.g., Peralta) to change the formula HR uses to account for these additional hours worked?

\$\Rightarrow\$A. AFA's Negotiations team will address this issue.

Q: Are faculty aware of this program?

⇒A. It is unknown how many faculty are aware of this revised program. Perhaps AFA can initiate a flex event on the topic.

Kat concluded by thanking those who attended.
