our esteemed colleagues, "I implore you, as our faculty union, to please fight for Emeritus Hall faculty to have decent working conditions as soon as possible." AFA is committed to serve our members, and so we'll continue to help our district colleagues keep Emeritus squarely at the center of your attention.
