AFA Report to Board of Trustees, 12/8/20, Sean Martin, AFA President

President Burns, Trustees, President Chong, Colleagues and other members of the community,

To begin, AFA leaders would like to congratulate Caroline Bañuelos on her election and welcome her to the Board of Trustees. Congratulations are also due to Mariana Martinez for her re-election to the board. We thank you for your service to the College and we look forward to a long and productive relationship with you both.

We also wish to express our thanks to Jordan Burns for his service as President of the Board and welcome Dorothy Battenfeld as she embarks on her term in that role. Again, we thank you both for all you do for the district.

I think we can all agree that Fall 2020 has tested our mettle. We've witnessed altogether too much suffering these last several months. We haven't always met the challenge as well as we would have wished. There has been much cause for disappointment and no shortage of disagreement. You've all heard a bit of that from me in these reports. And, we're eager to contribute to the development of an effective enrollment management plan.
